# Integrated Care Updates

#### CMS Issues Medicaid Capitation Rate Guidance for PACE

The Centers for Medicare & Medicaid Services (CMS) has issued <u>new guidance</u> for states to assist them in setting Medicaid capitation rates under Programs of All-inclusive Care for the Elderly (PACE).

The focus of the guidance is on the supporting documentation that states should submit to their CMS regional office for review and approval of a state's proposed PACE rates. In accordance with 42 CFR 460.182, the rates must: (1) be less than the amounts that would have been paid under the Medicaid state plan if the beneficiaries were not enrolled in PACE; (2) take into account the frailty of PACE participants; and (3) be a fixed amount regardless of changes in a participant's health status during the rate year.

### **December 2015 Enrollment in Medicare-Medicaid Plans**

Between November and December, total MMP enrollment in the nine states (CA, IL, MA, MI, NY, OH, SC, TX, and VA) currently implementing capitated model financial alignment demonstrations decreased slightly from 378,640 to 371,358 as shown in ICRC's table <u>Monthly Enrollment in Medicare-Medicaid Plans by Plan and by State, December 2014 to December 2015</u>.

## **Enrollment in PACE Organizations**

PACE organizations provide comprehensive medical and social services to frail, community-dwelling individuals age 55 and older, most of whom are Medicare-Medicaid enrollees. As shown in ICRC's table <u>Program of All Inclusive Care for the Elderly (PACE)</u> <u>Total Enrollment by State and by Organization</u>, there were a total of 34,038 PACE individuals enrolled in the 117 PACE organizations in December 2015, operating in 32 states. Enrollment rose approximately three percent since September 2015.

January 12	MA application forms for calendar year 2017 released.
February 17	MA applications for CY 2017 due to CMS.
