Integrated Care Update

2018 Medicare Advantage Star Ratings Released

The Medicare Advantage (MA) star ratings for calendar year 2018 are now available. The Centers for Medicare & Medicaid Services (CMS) publishes the star ratings each year to help beneficiaries find the best plan for them and to determine MA quality bonus payments to plans. States can use the ratings to help assess the plans operating in their state, especially Dual Eligible Special Needs Plans (D-SNPs) with which they may have contracts to provide services to Medicaid beneficiaries. In reviewing the ratings, note that:

- The lowest-ranking plans receive one star, and the highest ranking plans receive five stars.
- Star ratings are assigned at the contract level, not at the individual plan level. A single
 MA contract may include more than one type of Special Needs Plan (SNP) (i.e., chronic
 condition, institutional, and/or dual eligible), as well as non-SNP MA plans. A single MA
 contract may also include plans in more than one state. The star rating assigned to the
 contract applies to all plans under the contract.

To find star ratings for D-SNPs in your state:

- Find D-SNPs operating in a state, their MA contract number, and current enrollment.
 CMS publishes monthly <u>SNP Comprehensive Reports</u> that can be sorted by state, SNP type, and MA contract number and include enrollment numbers for each individual SNP.
- Access the 2018 Star Ratings for MA contracts including SNPs. Once a SNP contract number has been identified in Step 1 above, use the 2018 Report Card Master Table file within the ZIP file 2018 Part C and D Medicare Star Rating Data to find details on the D-SNP's star ratings. The "Summary Rating" tab shows summary ratings for Part C, Part D, and overall for each contract. The Master Table also contains a "Low Performing Contracts" tab for contracts that had Part C and/or Part D ratings of 2.5 stars or less from 2016 through 2018. These contracts are assigned a "Low Performing Icon" (LPI) in the star ratings and are subject to termination by CMS. For the first time since the implementation of the LPI, no contracts will receive the LPI for 2018.

November 2017 Enrollment in Medicare-Medicaid Plans

Between October and November 2017, total Medicare-Medicaid Plan (MMP) enrollment in the ten states (CA, IL, MA, MI, NY, OH, RI, SC, TX, and VA) currently implementing capitated model Financial Alignment Initiative demonstrations decreased slightly from 408,934 to 408,257 as shown in ICRC's table Monthly Enrollment in Medicare-Medicaid Plans by Plan and by State, November 2016 to November 2017.

November 2017 Enrollment in PACE Organizations

PACE organizations provide comprehensive medical and social services to frail, community-dwelling individuals age 55 and older, most of whom are Medicare-Medicaid enrollees. As shown in ICRC's table Organization, in November 2017 there were 124 PACE organizations operating in 31 states. Between October and November 2017, total PACE enrollment increased from 40,379 to 40,607.
