Integrated Care Update

Medicare-Medicaid Coordination Office FY 2017 Report to Congress

On June 18, the Centers for Medicare & Medicaid Services (CMS) provided Congressional leaders with the <u>Medicare-Medicaid Coordination Office FY</u> <u>2017 Report to Congress</u>, as required by statute. This report includes an overview of CMS activities, accomplishments, and ongoing work to improve care for the 11.7 million who are dually eligible for the Medicare and Medicaid programs. The number of dually eligible individuals enrolled in some type of integrated programs rose from about 162,000 in 2011 to nearly 790,000 in 2017. This includes the beneficiaries enrolled in the Medicare-Medicaid Financial Alignment Initiative demonstrations, the Program of All-Inclusive Care for the Elderly (PACE), and Medicare Advantage Dual Eligible Special Needs Plans (D-SNPs) closely aligned with Medicaid plans.

MedPAC and MACPAC June 2018 Reports to Congress

On June 15, the Medicare Payment Advisory Commission (MedPAC) released its <u>Report to the Congress</u>, and the Medicaid and CHIP Payment and Access Commission (MACPAC) also released its <u>Report to Congress</u>. These reports each contain information of interest to states seeking to better integrate care for dually eligible individuals. Chapter 3 of the MACPAC report examines the growth of Medicaid managed long-term services and supports programs. Chapter 9 of the MedPAC report examines managed care plans for dually eligible beneficiaries and provides an update on the Financial Alignment Initiative demonstrations. It also assesses three potential policies to encourage the development of plans that integrate care for individuals who receive both Medicare and Medicaid. ICRC plans to send a Spotlight email next week that examines the contents of these chapters in more detail.

Technical Assistance Available on HCBS Rate Development, Electronic Visit Verification Systems

CMS has contracted with Lewis and Ellis and Korn Ferry to offer free technical assistance to state Medicaid agencies on program and regulatory compliance for home- and community-based services rate setting and electronic visit verification. June 2018 Enrollment in Medicare-Medicaid Plans

Between May and June 2018, total Medicare-Medicaid Plan (MMP) enrollment in the nine states (CA, IL, MA, MI, NY, OH, RI, SC, and TX) currently implementing capitated model Financial Alignment Initiative demonstrations decreased slightly from 382,071 to 379,620 as shown in ICRC's table <u>Monthly Enrollment in Medicare-Medicaid Plans by Plan and by State, June 2017 to</u> <u>June 2018</u>.

June 2018 Enrollment in PACE Organizations

PACE organizations provide comprehensive medical and social services to frail, community-dwelling individuals age 55 and older, most of whom are dually eligible. As shown in ICRC's table, <u>Program of All Inclusive Care for the Elderly (PACE) Total Enrollment by State and by Organization</u>, 124 PACE organizations were operating in 31 states in June 2018. Between May and June 2018, total PACE enrollment increased from 41,917 to 42,151.

June 4	Deadline for plans to submit CY 2019 MA, MA-PD, MMP, and PDP bids; plans deciding not to renew their MA contracts must notify CMS in writing.
June 4	Organizations interested in offering a MA, PDP, or MMP product must submit a PBP that accurately describes the coverage details and cost-sharing for all covered benefits.
June 15	MedPAC and MACPAC reports to Congress released.
Key Upcoming Dates	
July 2	D-SNP applicants must submit State Medicaid Agency Contract (SMAC or "MIPPA contract") to CMS.
July 2	Deadline for D-SNPs requesting to be reviewed as Fully Integrated Dual Eligible Special Needs Plans (FIDE SNPs) to submit their FIDE SNP matrix to HPMS.
July 16	Due date for applications to the Administration for Community Living's <u>Alzheimer's Disease</u> <u>Programs Initiative (ADPI).</u>
